Notes on data processing

(just for information - note that the corresponding German version is legally binding)

1. Name and contact details of the responsible entity:

2. Collection and storage of personal data as well as the type and purpose and their use:

We collect the following information:

- title, first name, surname;

- type of membership

- a valid e-mail address;

- playing level

- address;

- bank account

- telephone number (fixed and/or mobile);

- Bemf (on a voluntary basis)

- Date of birth

The collection of this data is carried out

- to identify you as our club member

- for correspondence with you

- for club fee billing purposes.

The data processing is carried out at your request and is required by Art. 6 Para.1 S.1 lit.b DSGVO (GDPR) for the above-mentioned purposes for the mutual fulfilment of obligations arising from membership of the club. The personal data collected by us will be deleted one year after termination of membership.

3. Transfer of data to third parties

Your personal data will not be transferred to third parties for purposes other than those listed below. Insofar as this is necessary for membership of the club in accordance with Art. 6 Para. 1 S.1 lit.b DSGVO, your personal data will be passed on to third parties. This includes, in particular, the transfer to banks for the purpose of collecting membership fees and, if necessary, reporting to tennis umbrella organisations, for example within the framework of tennis tournaments.

4. Rights of persons concerned

You have the right:

- In accordance with Art. 7 Para. 3 DSGVO to revoke your consent to us at any time. As a result, we are no longer allowed to continue the data processing that was based on this consent for the future;

- to demand information about your personal data processed by us in accordance with Art. 15 DSGVO. In particular, you may request information on the purposes of the processing, the category of personal data, the categories of recipients to whom your data have been or will be disclosed, the planned storage period, the existence of a right of rectification, cancellation, restriction of processing or opposition, the existence of a right of appeal, the origin of your data, if not collected by us, and the existence of automated decision-making, including profiling and, where applicable, relevant information on the details of the data;

In accordance with Art. 16 DSGVO, to immediately demand the correction of incorrect or incomplete data stored by us;

- In accordance with Art. 17 DSGVO, to request the deletion of your personal data stored with us, unless the processing is necessary for the exercise of the right to freedom of expression and information, to fulfil a legal obligation, for reasons of public interest or for the assertion, exercise or defence of legal claims;

- to demand, in accordance with Art. 18 DSGVO, the restriction of the processing of your personal data if the accuracy of the data is disputed by you, if the processing is unlawful but you refuse to delete it and we no longer require the data, but you require it for the assertion, exercise or defence of legal claims or if you have lodged an objection to the processing in accordance with Art. 21 DSGVO;

- in accordance with Art. 20 DSGVO, to receive your personal data that you have provided to us in a structured, common and machine-readable format or to request that it be transferred to another responsible party and

According to Art. 77 DSGVO to complain to a supervisory authority, In general, you can do so by contacting the supervisory authority of your usual place of residence.

5. right of objection

If your personal data are processed on the basis of legitimate interests as per Art. 6 Par. 1 S.1 lit. f DSGVO, you have the right to object to the processing of your personal data in accordance with Art. 21 DSGVO, provided that there are reasons for this that arise from your particular situation.
